We are delighted that the London Summer Arbitration School 2024 will soon start in hybrid format. We would like to provide you with some additional information related to the summer school.

- **Teaching platform:** You can access our teaching platform following this <u>link</u> (https://adam.unibas.ch/goto_adam_crs_1735149.html). On this platform, which will regularly be updated, you will find:
 - the <u>programme</u> of the school providing you an overview about the course content and optional social activities;
 - the Zoom logins for our online participants; please note that there
 is a login for all classes, and two separate logins for the opening
 keynote and the closing keynote respectively (for the latter two
 you need to register in advance if you attend online, no need to
 register if you attend in person);
 - practical information, notably about the places where the school is hosted, lunch options, etc;
 - o all the **teaching materials** (reading assignments, legal instruments, guiding questions) and information about the **reflective journal**; please note that this section is still under construction as we expect additional materials from faculty members.
- Preparation: On the teaching platform, you find a section titled "Teaching Materials & Preparations"; please read it carefully in order to know which preparations are required. Please note that for most classes you will need to read materials in advance. We expect that all reading materials will be on the platform about a week before the beginning of the summer school and recommend that you start reading them now.
